TERMS AND CONDITIONS

PAYMENT TERMS

The customer understands that to be considered for spread payment terms a completed GeneMark® Account Application form must be completed. If required, the customer may also complete a direct debit form.

The customer must nominate the 12 months interest free option, meaning that:

- The customer agrees to pay the amount owed in 12 equal monthly spread payments.
- No interest will be charged on instalments.
- This payment term will be applied to dam submissions only, and.
- To be eligible for 12 months spread payment, the Dam samples submitted must equate to \$500 at the time of billing to trigger spread payments. E.g. $\$500/12 = \41.66 per month for 12 months
For example- this equates to a customer sampling a minimum 25 dams in any given month.

All instalments are due for payment on a monthly basis. Payments start following the first completed results.

SERVICES AND PRODUCTS NOT AVAILABLE FOR SPREAD PAYMENT

The customer acknowledges and accepts that the following products and services will not be available for the spread payment terms and payment will be required in full under the Standard Payment Terms when invoiced:

- BVD and A2 only testing.
- Charges associated with Allflex punches and applicators.
- Minimal sample numbers for outstanding/replacement animals

DEFINING ANIMAL GROUPS

Dams - all animals within the milking herd including carry overs.

CREDIT CHECKS

In accordance with the Privacy Act 2020 the customer hereby authorises LIC or any agent of LIC to conduct all credit checks and searches of the customer, and where the customer is a company, any director of that company and its financial and business affairs, as deemed necessary by LIC.

INVOICES & GST

The customer agrees that all services considered in this application are charged exclusive of GST. The customer shall be required to pay any GST content to LIC.

LIC shall issue a tax invoice/statement to the customer at any point when a payment is due to be made by the customer. Such invoices required to be issued shall meet the requirements of the Goods and Services Tax Act 1985. Such invoices shall include but not be limited to the deposit, progress payments, installments, interest (including any default interest) and any additional amount due pursuant to this application.

TURN AROUND TIME

Please allow 4-5 weeks for GeneMark to process and result samples for parentage, Genomic Evaluations can be up to a further 4 weeks. This is effective from the laboratory booking date. Samples may go 'on hold' if insufficient or incorrect information is submitted with the samples. Please read the customer requirements below.

CUSTOMER REQUIREMENTS

The customer understands that in order to achieve the best results from GeneMark Genomics, the customer must ensure that records are correct and updated on MINDA® records. Dam calving dates must be recorded, and all embryo transfer certificates sent to MINDA & the information is included on the submission form e.g. Donor, Recipient and Sire.

A DNA Sample should be submitted to GeneMark for any non-LIC bulls required for matching that do not have a G3 profile. A complete and signed submission form must accompany all samples.
